

NET ENERGY METERING (NEM) MANUAL APPLICATION FORM FOR PROPERTY DEVELOPERS

Open for registration starting **5th August 2019** by submitting a **Letter of Intent and Manual Application Form** (downloadable at www.seda.gov.my/reportal/nem) to SEDA Malaysia

1. Criteria for Quota Reservation for Property Developers:

- ☑ The Company/Property Developer must be incorporated in Malaysia.
- Application(s) must be made before **31st December 2020**.
- The total allowable project period is up to a maximum of <u>30 months</u> from the date of project commencement (property development).
- Applicable for Residential, Commercial and Industrial types of development, such as Small & Mediumsized Enterprise buildings and Government buildings.
- Approval to the NEM Applicant(s) or termed NEM Approval Holder is under the Developer's name and is transferable to the Purchase's/Buyer's with his/her applicable TNB account.

2. Terms and Conditions

a. Application requirements:

- Developers are required to ensure the pre-conditions below are fulfilled:
 - To submit approved Development Order plan inclusive of solar PV installation approved by the Local Authority
 - NEM Assessment Study shall be carried out for capacity > 72kW/unit (if applicable). The construction of
 interconnection point by developer shall include future solar capacity (New PE/upgrade PE).
- Developers are required to submit:
 - Letter of intent with information related wih the project development and other detail design inlcluding solar PV;
 - NEM manual application form for property developers;
 - NEM processing fee of RM1,000/application (non-refundable).
- ☑ Quota will be made based on first come first serve, final decision is at SEDA's discretion. Letter of award shall be issued to the successful Property Developer subject to the Authority's approval including the applicable conditions.

b. Upon approval of Quota Reservation

- The NEM application shall be carried out by Registered PV Service Provider (RPVSP) with SEDA Malaysia via eNEM online system upon approval issued by SEDA Malaysia.
 - NEM application fee is RM10/kW x kW/unit x no. of units (as stipulated in the NEM's guideline, non-refundable).
 - The company/property developer within <u>30 days of approval issued by SEDA Malaysia</u> shall provide a
 Performance Bond by an approved licensed bank of financial institution incorporated in Malaysia in
 favor of the SEDA Malaysia for a sum equivalent to RM100/kWac to secure the due performance of the
 NEM approval. The Performance Bond shall remain valid and effective from the date of approval letter
 of quota reservation until completion of NEM Commencement Date (NEMCD).

Note: The performance bond is refundable upon successful completion the project within the approved time frame, failing which, it will be forfeited.
