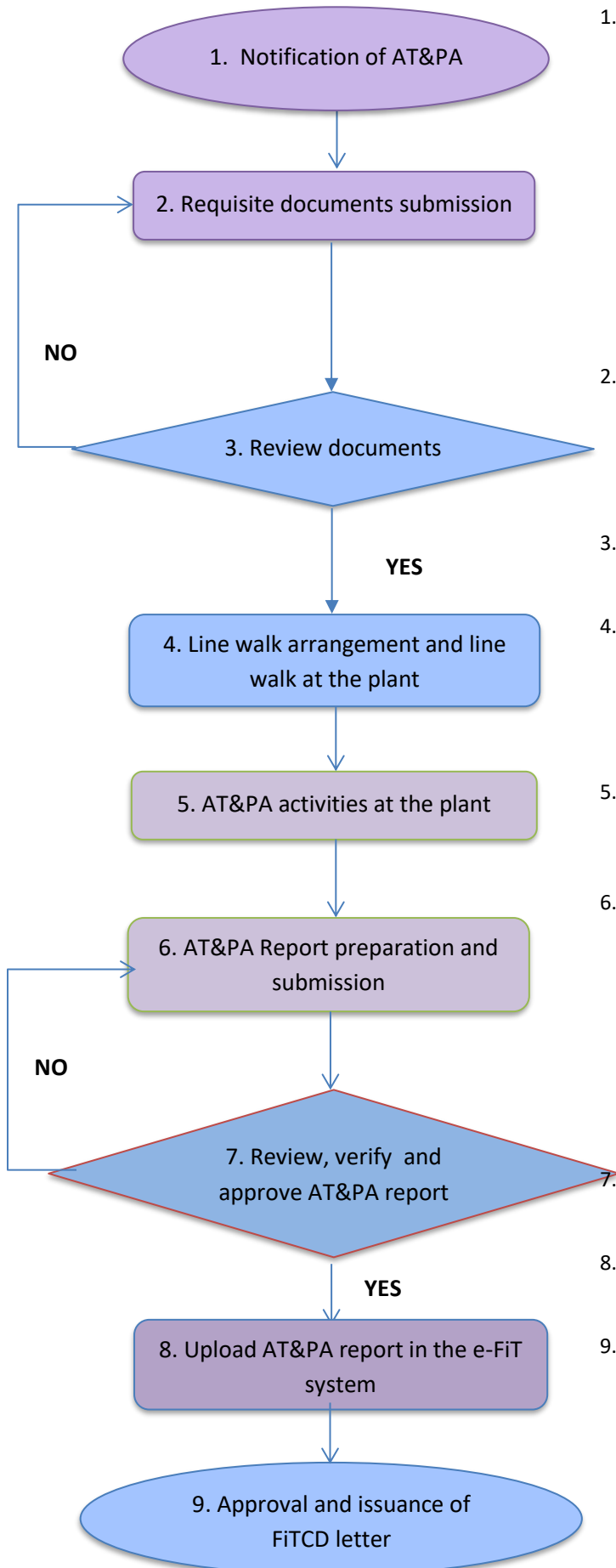


FLOW CHART OF ACCEPTANCE TEST & PERFORMANCE ASSESSMENT (AT&PA) OF BIOGAS POWER PLANTS UNDER THE FEED-IN TARIFF (FIT) PROJECTS IN MALAYSIA



1. FiAH/FiAH's Qualified Person submits an official notification to conduct the Acceptance Test & Performance Assessment (AT&PA) to SEDA Malaysia **NOT LESS than fourteen (14) days** on the AT&PA schedule.

2. FiAH/FiAH's Qualified Person to submit the requisite documents to SEDA Malaysia before executing AT&PA activities:
 a) Checklist of AT&PA documentation (**Form 1**);
 b) Information about the Project (**Form 2**);
 c) Information about the Plant (**Form 3**);

3. SEDA Malaysia reviews the requisite items and other related documents.

4. SEDA Malaysia notifies and arranges the line walk date. The line walk will be conducted with the presence of SEDA Malaysia Officer and FiAH/FiAH's Qualified Person.

Confirmation of AT&PA date

5. FiAH/FiAH's Qualified Person executes AT&PA activities with the presence of SEDA Malaysia Officer and relevant Competent Person engaged by FiAH.

6. FiAH/FiAH's Qualified Person finalize AT&PA Report. All AT&PA forms are required to sign by FiAH/FiAH's Qualified Person. The report shall consist of;
 a) Checklist of AT&PA documentation (**Form 1**);
 b) Information about the Project (**Form 2**);
 c) Information about the Plant (**Form 3**);
 d) Acceptance Test (**Form 4a**) & Reliability Run (**Form 4b**); and
 e) Fuel sampling (**Form 5a**) & Electrical Efficiency (**Form 5b**) – if required.

7. SEDA Malaysia reviews, verify and approves the AT&PA Report in Mesyuarat Jawatankuasa Operasi Pasaran (JKOP)

8. FiAH/FiAH's Qualified Person to upload the AT&PA report in the FiAH's e-FiT system (project milestone).

9. SEDA Malaysia finalizes the Feed-in Tariff Commencement Date (FiTCD) in the FiAH's e-FiT system. FiAH will receive an email notification and the letter of FiTCD will be issued upon request.
